4. FIRST AID MEASURES

7. HANDLING AND STORAGE

Handling: This product is combustible; do not open near an open flame, or sources of heat or ignition. Container should be kept closed, and should be opened slowly to control possible pressure release. Material will accumulate static charge, so grounding leads should be used to avoid discharge.

Storage: Store in a cool, dry place away from direct sunlight. Do not pressurize, cut, heat or weld the container,

11. TOXICOLOGICAL INFORMATION
